I was offered this position after working closing with the Counties Network and Security team on several large projects back in 2016. Since then I have lead and assisted on countless project across the org. This includes projects outside of IT like vendor selection for County employee recognition platforms as well as being being on the board to hire new employees.

Some of my recent project include:

- Automating Windows and macOS imaging and provisioning with Microsoft Intune and Ivanti End Point Manager. This project was aimed at reducing the deployment time for a computer to automating the OS install, and software installation for a computer based on which department the device was going to be used in. To date, the project is on track and team responsible for deploying those devices is on track to deploy around 500 new laptops and desktops this year.
- leading the team to migrate two of our data centers from NSX to NSX-T. This was a multi-month project designed to upgrade our micro-segmentation to the newest version. We had to review our networking configurations and create new jumbo frame vlans to route this new implementation between the DC's and their core routers. Once the networking was addresses, an entire overhaul of the ESXi systems took place. Overall it was a success, with our biggest challenge being on the network side.
- Migrating from our on-prem ADFS server connections to EntraID. This was a great project for me as it required me to work with with over 50 of our SaaS vendors to migrate services from one platform to another.
- I have also been working on the upgrade / migration of all our 2012 and 2008 Windows Servers to 2019 and 2022 Windows servers.
- Install/manage/upgrade datacenter equipment
- Public and Private DNS management
